WAIVER & RELEASE OF LIABILITY — PLEASE READ CAREFULLY

In consideration of being permitted to participate in the Nets for Vets Pickleball Tournament (the "Event"), held on October 3, 2026 (rain date October 4, 2026) at the Kellogg Community College Pickleball Courts, and hosted by American Legion Post 257, I, on behalf of myself and any minor participant I am registering, agree to the following terms.

Assumption of Risk

I understand that participation in pickleball and related tournament activities carries inherent risks, including but not limited to falls, collisions, muscle strains, sprains, fractures, cardiac events, and other physical injury, as well as risks of loss or damage to personal property. I voluntarily assume all such risks, known and unknown, arising from my participation, whether occurring before, during, or after the Event.

Release and Waiver of Liability

I hereby release, waive, discharge, and covenant not to sue American Legion Post 257, its officers, members, volunteers, and event organizers, Kellogg Community College and its employees and agents, and all sponsors of the Event (collectively, the "Released Parties"), from any and all liability, claims, demands, actions, or causes of action arising out of or related to any loss, damage, or injury, including death, that may be sustained by me or my property while participating in the Event, whether caused by the negligence of the Released Parties or otherwise, to the fullest extent permitted by law.

Medical Treatment

I certify that I am physically fit to participate in this Event and have not been advised otherwise by a qualified medical professional. I consent to receive emergency medical treatment, including transportation to a medical facility, in the event of injury or illness during the Event, and I understand I am responsible for any associated costs.

Photo & Media Release

I grant American Legion Post 257 permission to photograph and video record me during the Event and to use those images or recordings for promotional, fundraising, and community purposes, without compensation to me.
